Booking // To secure the date and time of your ceremony, either full payment or non-refundable booking fee of \$400 is required. If your date is secured with the non-refundable booking fee, the balance of the ceremony fee is due no less than 1 calendar month prior to the date of the marriage.

Elopement / Legals only marriage ceremony inclusions

1. A highly experienced, friendly, knowledgeable, and organised Celebrant to deliver your marriage ceremony.
2. Initial meeting with you both (either in person in Brisbane or via video call) to confirm the inclusions of your ceremony enabling the Celebrant to prepare your marriage ceremony wording.
3. Completion of required marriage paperwork, including lodgement of NOIM (Notice of Intended Marriage form), sighting of identification.
4. Simple elopement or 'Legals only' standard ceremony wording provided to you (once payment has been received) so you know exactly what to expect on the day. Please be advised a fully personalised ceremony is not included in the minimum rate and may be quoted upon request.
5. Optional complimentary use of signing table.
6. Your marriage date and timeslot secured exclusively for you.
7. Email support to ensure any questions are answered.
8. Your simple ceremony professionally and authentically delivered on the day.
9. Your marriage documents submitted to BDM QLD and email notification that your documents have been lodged.
10. Changing your name through marriage process and check list information provided after the ceremony has taken place.

Extras

- Travel and parking fees: There is no travel for marriages that take place at our recommended elopement locations including Indooroopilly, Mt Coot-tha, New Farm and Kangaroo Point. Other locations may incur a travel or parking fee. Quoted upon request.
- If you require an official registry issued marriage certificate issued by BDM QLD, we will happily assist you with applying for this, the fee is approximately \$55+postage and is payable by you directly to BDM QLD at the time they register your marriage.
- Use of PA System - For ceremony audio is recommended when 12 or more guests are expected. Please note, PA System may also be utilised for ceremony music, with the couple providing a playlist on a mobile phone, and delegating a guest or venue staff to be in charge of playing the music on the day.
- Visa letter confirming marriage booking if required for fiancé visa applicants.

PLEASE NOTE

- (1) Your marriage date and time is secured on receipt of your non-refundable booking fee or full payment.
- (2) Fees are subject to change. Fee changes do not apply to clients who have secured their date with a non-refundable booking fee or full payment.
- (3) If full payment is not received by 30 days prior to the ceremony date, elope.net.au reserve the right to withdraw from their obligation to perform the marriage.
- (4) Conditions of service agreement apply; service agreement is outlined on the 'Ceremony Details Form'.

Refund Policy // The \$400 booking fee is non-refundable as this covers the date and time being exclusively held and the work already performed including meeting couple to discuss requirements, completing, lodging and auditing marriage paperwork and all communications to date. If the marriage has been paid for in full and notice of cancellation of the marriage is provided no less than 60 days prior to the date of the marriage, the fee paid, less the non-refundable booking fee (\$400) may be refunded.

If less than 60 days' notice of cancellation is provided, all fees paid are non-refundable.

One complimentary postponement is included within the NOIM validity period. Subsequent postponements incur a \$150 administration fee. Postponements made less than 30 days before the date of the marriage also incur a \$50 marriage stationary replacement fee. Once a booking is postponed, this becomes a non-refundable credit note, valid up to 6 months from the original marriage date.
